The table sets out offence creating sections of the *Criminal Code*, followed by a short title of the corresponding offence and the maximum penalties that apply in various circumstances. The table then identifies which court has jurisdiction to hear and decide the charge by identifying the relevant section of the *Criminal Code*, the *District Court of Queensland Act 1967* (Qld) or the *Supreme Court of Queensland Act 1991* (Qld).

Where summary jurisdiction is given under s552BA of the *Criminal Code*, there is a corresponding Note to see s552D which requires a Magistrates Court to abstain from dealing summarily with a charge under section 552BA if satisfied, on an application made by the defence, that because of exceptional circumstances the charge should not be heard and decided summarily.

Where summary jurisdiction is given under s552B of the *Criminal Code*, it is subject to the Defendant having the right to elect to be dealt with on indictment in the District Court. Similarly, where jurisdiction is vested in the District Court under s552A of the *Criminal Code*, it is subject to the Prosecutions election to have the matter dealt with summarily.
